# A. <u>GU-ART Coverage:</u>

- Admission to the Post Graduate Programmes shall be based on GU-ART. For details of Programmes offered at the University Schools and Affiliated Colleges, Seat Matrix and Reservations refer <u>Annexure I</u> & <u>Annexure II</u> respectively.
- Admissions to the B. Ed Programme for the academic year 2025-26 offered at the Affiliated Colleges shall also be based on the GU-ART along with the other eligibility criteria as prescribed in <u>Annexure III-A</u> by the Directorate of Higher Education (DHE), Government of Goa.
- 3. Admission to the following Post-Graduation Degree Programmes shall not be based on GU-ART:
  - M.B.A. Goa Business School, Goa University
  - M.B.A. (Executive), Goa Business School, Goa University
  - M.B.A. (Integrated), Goa Business School, Goa University
  - M.B.A. (Financial Services), Goa Business School, Goa University
  - M.B.A. (Integrated in Hospitality & Tourism), Goa Business School, Goa University.
  - M.Sc. (Integrated) Data Science, Goa Business School, Goa University

- M.Sc. (Integrated) Economics, Goa Business School, Goa University
- M.Sc. Marine Biotechnology, School of Biological Sciences & Biotechnology, Goa University.
- M.Sc. International Hospitality and Tourism Management program (M.Sc. IHTM), V. M. Salgaocar Institute of International Hospitality Education

# **Eligibility:**

Admissions to the Post Graduate Programmes shall be entirely based on the **Goa University - Admissions Ranking Test (GU-ART)**. The marks/percentage obtained by the candidate while graduating would only be used to ascertain the eligibility of candidates for the Programme. The purpose of the GU-ART is only to rank the prospective candidates and not for determination of pass/fail, except in case of M.C.A; kindly refer to <u>point no.5 under</u> <u>section C</u> of GU-ART Coverage for admission details to MCA Programme.

# Candidates who are in their Final Year of Graduation are also eligible to apply.

Selected candidates who are in the Final Year of Graduation shall be granted Provisional Admission. Their admission shall be confirmed after the UG results are declared based on the eligibility. In case a candidate fails to clear the Graduation Examination, the admission shall stand canceled and the fees shall be refunded.

The Eligibility for admission to the various Programmes and for Change of Discipline is given in <u>Annexure VI</u>. The Eligibility for admission to the B.Ed. Programmes are given in <u>Annexure III-A</u>.

5. Candidates aspiring to take admission to M.C.A., M.Sc. Artificial Intelligence and M.Sc. Data Science Programmes shall be subject to the candidate fulfilling all the eligibility criteria of the respective Programme as mentioned in <u>Annexure V</u>.


The candidates must attend the counselling to be eligible for allotment of seats. No seats shall be allotted to the candidates who remain absent during the time of Counselling.

# B. Filling up of the Online Application Form:

Admissions Portal Link: https://unigoaadmission.samarth.edu.in

- a) The LAST DATE for submission of applications is 10<sup>th</sup> February 2025.
- b) Candidates are advised in their own interest to apply online much before the closing date and not wait till the last date for applying/payment of application fee to avoid the possibility of disconnection/inability/ failure to log on to the website on account of heavy load on the website.
- c) Goa University does not assume any responsibility to candidates in case they are unable to submit their application by the last date on account of the aforesaid reasons or for any other reason beyond the control of the University.
- d) Additional time shall not be provided under any circumstances for submission of any Certificates after the last date of application.

- e) The softcopy of the Passport size photograph and Signature provided by the candidate has to be according to the specification mentioned below:
  - i. Digital Photo and Signature are required in .jpg or .jpeg image format.
  - ii. File size of digital photo must be within 10kb to 500 KB limit.
  - iii. The face must take up 70-80% of the photo.

- iv. The same photograph and signature shall be used to issue Admit Cards for GU-ART, for issuance of University ID card and Examination Registration Process.
- v. Candidates shall not upload Selfies or photos of passport size photograph.
- vi. Student should mandatorily have the following documents in specified format to complete the online application. (Note: The documents to be uploaded should be in pdf / JPEG / JPG / format with file size 10KB-500KB)
  - SSC Marksheet, HSSC Marksheet, UG Marksheet, PG Marksheet. (PDF format)
  - Income Certificate, Sports Certificate, Cultural Activity Quota Certificate (PDF/JPEG/JPG)
  - Recent Passport Size Colored Photograph (JPEG / JPG)
  - Reservation category certificate SC/ST/OBC/EWS/PwD. (PDF format)
  - Declaration of Only Girl Child. (PDF/JPEG/JPG) on plain A4 size paper only.
- f) Printout of the application form is <u>NOT REQUIRED</u> to be submitted to the University.

# Application Fees (Non-refundable) (To be paid online through Samarth portal only):

- INR 750 in case candidates belonging to Un-reserved/ EWS/OBC(NCL) for first application per subject/specialization, and INR 600 in case of every subsequent application in subject/specialization.
- INR 375 in case of Candidates belonging to SC/ST category from Goa per subject/specialization, and INR 300 in case of every subsequent application in subject/specialization.
- No fees shall be charged from Persons with Disability.

\*Candidates applying for admission under these categories shall be required to submit a valid Certificate to that effect issued by the Officer of the rank of the Deputy Collector or any other authorized Officer as notified by the Government of Goa.

# C. <u>GU-ART:</u>

Candidates are requested to note the following details regarding the GU-ART.

- 1. Candidates shall be permitted to apply for a maximum of five subjects/specializations for the PG and/or B.Ed. Programmes.
- 2. Candidates who wish to apply for more than one programme are required to use the same login details. No changes shall be entertained after the application is submitted online.
- 3. The GU-ART shall be of One Paper of 100 marks, containing 50 objective Multiple-Choice Questions (MCQ) of 2 marks each. There shall be negative marking, where half a mark shall be

deducted for each wrong answer. No marks shall be deducted for unanswered questions. The duration of the GU-ART shall be 90 minutes.

- 4. The breakup of 100 marks for the GU-ART Question Paper shall be as follows
  - a. Section I (Least difficult)

- 15 Questions

b. Section II (Difficult)

- 15 Questions

c. Section III (Most difficult)

- 20 Questions
- 5. Details of Admission Test for MCA, M.Sc. Artificial Intelligence and M.Sc. Data Science Programmes
  - a. The admission test for MCA, M.Sc. Artificial Intelligence and M.Sc. Data Science shall be based on the syllabus notified by Goa University which consists of Analytical Ability and Logical Reasoning, Mathematics and Computer Science. There shall be common test for candidates applying for MCA, M.Sc. Artificial Intelligence and M.Sc. Data Science.
  - b. The GU-ART shall be of One Paper of 100 marks, containing 50 objective Multiple-Choice Questions (MCQ) of 2 marks each. There shall be negative marking, where half a mark shall be deducted for each wrong answer. No marks shall be deducted for unanswered questions. The duration of the GU-ART shall be 90 minutes
    - The breakup shall be as follows:
    - a. Section I Analytical Ability and Logical Reasoning 15 Questions
    - b. Section II Mathematics 10 Questions
    - c. Section III Computer Science 25 Questions
  - **c.** To qualify for admission to MCA, a candidate is required to score a minimum of 30% marks (percentage obtained by the candidate to be rounded up to the next integer) with 5% relaxation for SC/ST/OBC(NCL) category candidates in the Admission Test. Merit list shall be generated based on the performance in the Admission Test.
  - **d.** For M.Sc. Artificial Intelligence and M.Sc. in Data Science, Ranking list shall be generated based on the performance in the GU-ART. There shall not be any cut off percent.
- 6. In case candidates who have answered the GU-ART and have secured equal marks in the ranking list:
  - a. Section III scores shall be the first level of tie breaker, followed by Section II
  - b. In case the tie still exists, the University shall decide the order of merit.

- 8. A Common GU-ART shall be conducted for admission to
  - a. M.A. Psychology, MA Wellness Counselling and Post Graduate Diploma in Guidance Counselling
  - b. M.C.A., M.Sc. Artificial Intelligence and M.Sc. Data Science
- 9. Additional GU-ART Rounds shall be conducted only if seats remain vacant in the respective subject/specialization of the Programmes. However, candidates answering the subsequent GU-ART Rounds shall be ranked after the candidates who has answered previous Round. Example: If 100 candidates apply for Round I, all 100 shall be assigned a rank based on the marks scored. For Round II, candidates shall be ranked from 101 onwards. The candidate scoring highest marks at GU-ART Round II shall be ranked 101.

The Test Centre for the First Round of GU-ART (candidates answering in Offline Mode) shall be mentioned on the Admit Card.

The Log-in credentials for the Other University candidates answering the GU-ART in Online Mode, shall be shared with the candidates separately, on the registered email-id.

# E. Admission Process:

- 1. The results of **GU-ART Round I** shall be displayed on the Goa University Website.
  - a. For Programmes offered only at the University Schools or at a single affiliated College, the seats shall be allotted to candidates based on their performance in the GU-ART. Rules/Guidelines for allotment of seats are given in <u>Annexure VII.</u>
  - b. For Programmes offered at both the University as well as the affiliated colleges or at multiple colleges, seats shall be allotted through PHYSICAL COUNSELLING which shall be held at the Goa University Campus (click here to refer List of Programmes).
- 2. All Candidates including those who are Selected/Allotted/Offered seats at the Goa University Schools or Affiliated Colleges shall be required to pay the Seat Confirmation Fee of Rs.10,000/- in online mode on the Samarth Portal.
- **3.** Reserved Category Seats remaining vacant after the 1<sup>st</sup> Provisional List of the First Round of GU-ART shall be transferred to the Un-reserved Category.
- 4. PHYSICAL COUNSELLING dates shall be notified on Goa University Website.

The Institution selected at the time of filling the Samarth Registration form shall not be considered as final preference. The institute shall be allotted as per the availability of seats in the concerned institute at the time of Physical Counselling. The candidates must attend the counselling to be eligible for allotment of seats. No seats shall be allotted to the candidates who remain absent during the time of Counselling.

There shall be common Counselling for the following Programmes:

- a) M.C.A, M.Sc. in Artificial Intelligence and M.Sc. in Data Science
- b) M.A. Psychology and M.A. Wellness Counselling

#### A] Shenoi Goembab School of Languages & Literature:

#### Master of Arts English, French, Hindi, Konkani, Marathi and Portuguese:

To be eligible for admission to the Programmes leading to the Degree of Master of Arts, a candidate shallhave passed the examination of Degree of Bachelor of Arts General/ Honors of the University in the subject for which admission is sought or an examination of any other University recognised as equivalent thereto.

#### B] DD Kosambi School of Social Sciences & Behavioural Studies:

#### i) Master of Arts in History, Political Science, Sociology, Geography and Psychology:

To be eligible for admission to the Programmes leading to the Degree of Master of Arts a candidate shall have passed the examination of Degree of Bachelor of Arts (B.A.) General/ Honors in the subject for which admission is sought of the University or any other University recognised as equivalent thereto.

#### ii) Master of Social Work:

To be eligible for admission to the Programmes leading to the Degree of Master of Social Studies a candidate must have completed graduation in any discipline from this University or any other University recognized as equivalent thereto.

#### iii) Master of Arts in Women's Studies:

To be eligible for admission to the Programmes leading to the Degree of Master of Arts in Women's Studies, a candidate must have completed graduation in any discipline from this University or any other University recognized as equivalent thereto.

#### C] Goa of Business School:

#### i) Master of Arts in Economics:

To be eligible for admission to a Programme leading to the Degree of Master of Arts in Economics, a candidate must have passed the examination of Degree of Bachelor of Arts General/ Honors of the University in the subject for which admission is sought or an examination of any other University recognised as equivalent thereto.

#### ii) Masters of Commerce (M. Com):

Passed Graduation in a Non-Computer Science discipline with Mathematics at 10+2 level or at Graduation level with at least 50% marks (5% relaxation in minimum percentage for candidates belonging to SC/ST/OBC (Non-Creamy Layer)/PwD shall be applicable as per State Government Rules). Such candidates shall be provisionally admitted until successful completion of Bridge Courses. c. Admission to Semester III (Applicable for Non-Computer Science Graduates): The Non-Computer Science candidates are required to successfully complete the Bridge Course(s) before admission to the third Semester. To be considered successful, the student is required to obtain a minimum of 40% marks separately in the Theory and Laboratory components. The assessment of the Bridge course(s) shall be conducted by the Goa Business School.

Candidates shall have to complete Bridge Courses via self-study. Candidates are preferably advised to undergo the Bridge courses before the start of the programme.

# iv) M.Sc. Artificial Intelligence and M.Sc. Data Science

OR

Any Bachelor Degree in Engineering (except Computer Science/Information Technology/ Data Science/ AI) with at least 55% marks. Such candidates shall be provisionally admitted until successful completion of Bridge Courses.

Candidates shall have to complete Bridge Courses via self-study. Candidates are advised to undergo the Bridge courses before the start of the programme.

iii. 5% relaxation in minimum percentage of qualifying examination for candidates belonging to SC/ST/OBC (Non-Creamy Layer)/PwD shall be applicable as per State Government Rules.

# v) Master of Library and Information Science (M.L.I.Sc):

Graduates in any discipline of the University or any other University recognized as equivalent thereto shall be eligible to apply for admission. A student exiting the M.L.I.Sc. Programme after successfully completing one year (40 Credits) shall be awarded B.L.I.Sc. Degree. A student who have completed the B.L.I.Sc. shall be offered admission for Semester III of M.L.I.Sc. programme.

(iv) Post Graduate Diploma in Clinical Genetics and Medical Laboratory Techniques (PGDCGMLT) A candidate for being eligible for admission to the Diploma in Clinical Genetics and Medical Laboratory Techniques must have passed the examination of degree of Bachelor of Science of this University or from any other recognized University, with at least 32 credits in the first, second and third years taken together under the Choice Based Credit System (CBCS) in the subject of either Zoology, Microbiology, Biotechnology, Chemistry/Biochemistry. In Semester system of examination, the number of papers or units shall be 14, with a total of 1400 marks, out of which eight papers are studies in F.Y. and S.Y. taken together and minimum 6 papers in T.Y. for being eligible for PG admission in that subject

# F] School of Chemical Sciences:

#### i) Master of Science in Chemistry:

- a) To be eligible for admission to a Programme leading to the Degree of Master of Science in Chemistry, a candidate must have passed the examination of the Degree of Bachelor of Science of the University General/ Honors or from any other recognized University, in the subject for which admission is sought.
- b) Candidates applying for admission to the M.Sc. Programme in Chemistry shall be eligible to be admitted to only one of the various specializations at M.Sc., Part II, as notified in the University Prospectus.

To be eligible for admission to a Programme leading to the Degree of Master of Science in Applied Geology, a candidate must have passed the examination of the Degree of Bachelor of Science General/ Honors of the University or from any other recognized University, in the subject for which admission is sought.

## (ii) Master of Science in Marine Science:

a) To be eligible for admission to a Programme leading to the Degree of Master of Science in Marine Science Programme, a candidate must have passed the examination of the Degree of Bachelor of Science of the University or from any other recognized University,

in Mathematics/Physics/Chemistry/Biology/Hydrochemistry/EnvironmentalScience/ Environmental Chemistry/ Marine Science/Ocean Science/Biotechnology. A candidate with BSc Geography /B.C.A with mathematics at HSSC level is also eligible.

## (iii) Master of Science in Marine Microbiology:

To be eligible for admission to a Programme leading to the Degree of Master of Science in Marine Microbiology, a candidate must have passed the examination of the Degree of Bachelor of Science General/ Honors in Microbiology/ Biotechnology of the University or from any other recognized University.

#### (iv) Master of Science in Environmental Science

To be eligible for admission to a Programme leading to the Degree of Master of Science in Environmental Science, a candidate must have passed the examination of the Degree of Bachelor of Science General/ Honors of the University or from any other University

#### H] School of International and Area Studies:

#### (i) MA International Studies:

To be eligible for admission to the Programmes leading to the Degree of Master of Arts in International Studies, a candidate must have completed graduation in any discipline from this University or any other University recognized as equivalent thereto.

#### I] Manohar Parrikar School of Law, Governance & Public Policy:

#### (i) Master of Arts in Public Administration:

To be eligible for admission to the Programmes leading to the Degree of Master of Arts in Public Administration, a candidate must have completed graduation in any discipline from this University or any other University recognized as equivalent thereto.

## CHANGE OF DISCIPLINE

 <u>Change of Subject for Candidates for Master of Arts / Master of Commerce Programmes:</u> Candidates who have passed Bachelor's Degree examination in any subject of this University or any other recognized University and secured at least 40% of the aggregate marks in their qualifying examination may seek admission to the Master of Arts Degree Programme/ Master of Commerce Programme in a subject of their choice.

# 2. <u>Change of Subject for Candidates for Master of Science Programmes:</u>

Candidates who have passed Bachelor's Degree examination in any Science subject of this University or any other recognized University and secured at least 40% of the aggregate marks in their qualifying examination may seek admission to the Master of Science Degree Programme subject to the following:

- i. Candidates who intend to apply for the M.Sc. Programmes in the discipline in which they have not studied at the undergraduate level are required to answer the Change of Discipline Test (CDT) in addition to the Ranking Test in the respective subject.
- ii. The CDT shall be on the lines of the Ranking Test. Candidates are required to score a minimum of 50% marks in the CDT to pass the test.
- iii. The CDT shall be conducted prior to the Ranking Test, by the respective School. In case the programme is not offered at the University School, then the Test shall be conducted at the college offering the programme designated by the University.
- iv. Only qualified candidates will be eligible to answer the Ranking Test in the respective subject.
- v. The CDT will be conducted only once in a year before the first Round of Ranking Test, tentatively by <u>20<sup>th</sup> February 2025</u> in offline mode.
- vi. The Eligibility for the CDT shall be as per OA-20.

# Change of Discipline Test:

The Change of Discipline Test shall be of 50 MCQ each carrying 2 marks for the correct answer and 0.5 negative (-ve) marks for a wrong answer. No marks shall be deducted for unanswered questions. The duration of the Test shall be of 90 minutes. Candidates are required to score a minimum of 50% marks in the Change of Discipline Test to pass the test.

Under the scheme of Change of Discipline, the candidates who have qualified the CDT and answered the Ranking Test shall be considered eligible for admission against the vacant seats available, if any, after students from the merit lists of concerned Programme are given admission.

Under the scheme of Change of Discipline, up to two seats may be made available as supernumerary with the approval of Vice-Chancellor, if no vacant seats are available for the qualified candidates and if the normal supernumerary seats are not filled.

The candidate should have Bachelor's Degree in Botany/ Zoology/Biotechnology/ Biochemistry/ Life Sciences/ Biological Sciences/ Home Science/Paramedical/ Physician Assistant/ Clinical Sciences / Forensic Science OR four-year Bachelor's Degree in M.B.B.S./ B.A.M.S./ B.H.M.S./ Physiotherapy/Nursing/Agriculture/ Veterinary/ Forestry/ Pharmacy/ Fishery Sciences/ BDS/B.E.(Biochemical / Medical / Biotechnology)/ B.Tech (Biochemical / Medical/Biotechnology/ Food Science.

#### **SESSION 1 & 2 OF COUNSELLING**

Counselling process shall be conducted in two sessions i.e. during Session 1 seat shall be allotted based on seat matrix. After the conclusion of Session 1, vacant reserved category seats shall be transferred to Un-Reserved Category.

During Session 2, resultant UR Category vacant seats shall be filled.

List of selected candidates of such programmes shall be declared on the University website after the Counselling. Selected Candidates shall be offered admission on a provisional basis and shall have to pay the Seat Confirmation Fee of INR. 10,000/- on Samarth. The last date of payment shall be notified.

# <u>General</u>

- 1. Seats under Un-Reserved category shall be filled first as per merit, followed by respective reserved categories.
- 2. If a candidate after securing admission to a programme wishes to transfer her/his seat from a University School to another or from a College programme to University School and vice versa her/his fee shall be is transferred or refunded as per UGC Rules.
- 3. All Seats which were allotted at Round I but were not confirmed by the candidates by payment of Seat Confirmation Fees shall be offered to other eligible candidates based upon their merit.
- 4. Vacant Reserved category seats after 1<sup>st</sup> Provisional List of Round I shall be transferred to Un-Reserved Category only.
- 5. Post declaration of the qualifying examination results, eligible candidates shall submit the Documents for verification and enroll for the programme by paying the balance fees.
- 6. The Seat Confirmation Fee is fully refundable in case of withdrawal of provisional admission within 30 days from the last date of Admission.
- 7. Fees shall be fully refundable in case a candidate fails to qualify the UG Examination.
- 8. Refer <u>Annexure IX</u> for details of the Refund of Fees.

#### **RESERVATION GUIDELINES**

Reservation of seats for admission to the various Programmes of study shall be on the basis of the Reservation Policy of the Goa State Government.

Candidates applying for admission under the Reserved Categories shall be required to submit a valid Certificate to that effect issued by the Officer of the rank of the Deputy Collector or any other authorized Officer as notified by the Government of Goa.

- 1. 2% of seats in each of the post-graduate programmes of study, subject to a minimum of one seat, shall be reserved for candidates belonging to SC Category of Goa State.
- 2. 12% of seats in each of the Post-Graduate programmes of study, subject to a minimum of one seat, shall be reserved for candidates belonging to ST Category of Goa State.
- 3. 27% of total seats, subject to a minimum of two seats, for admission to various programmes of study, shall be reserved for candidates belonging to the Other Backward Classes Non-Creamy Layer (OBC-NCL) of the State of Goa as per the directives of the State Government.
- 4. 5% of total seats, subject to minimum one seat for admission to the various programmes of study, shall be reserved for **Person with Disability (PwD)** candidates as per State Government directives.
- 5. 10% of seats, shall be made available for candidates of other Indian Universities.
- 6. 10% of total seats shall be reserved for Economically Weaker Section of Un-Reserved Category (EWS) as per the directives of the State Government.
- 7. 1% of total seats shall be reserved for Children of Ex- servicemen.
- 8. 15% of seats, over and above the allotted number of seats, shall be reserved as supernumerary seats for the overseas candidates, who are eligible for admission and are recommended by the Govt. of India under Scholarship from Govt. of India or under exchange programme (ICCR Programme). These seats shall be filled in accordance with the UGC Guidelines. Out of the 15% supernumerary seats, one seat in each program will be reserved for Kashmiri Migrants (KM) as per directives of the UGC.

\*Percentage of seats mentioned above is subject to change depending upon the Directives of the Goa State Government.

a) If a student chooses to withdraw from the programme of study in which s/he is enrolled, the following five tier system shall be followed for the refund of fees remitted by her/him.

Sr. No.	Point of time when notice of withdrawal of admissionis served to the Institution	% of refund of Aggregate fees*
1.	15 days or more before the formally notified last date of admission. #	100%
2.	Less than 15 days before the formally notified last date of admission.	90%
3.	15 days or less after the formally notified last date of admission.	80%
4.	30 days or less, but more than 15 days after the formally notified lastdate of admission.	50%
5.	More than 30 days after the formally notified last date of admission.	0%

\* Inclusive of tuition fees and non-tuition fees but exclusive of Caution Deposit # Last date of admission shall be notified later on the university website.

- b) In case of (1) in the table above, 5% of the aggregate fees paid by the student, subject to a maximum of Rs. 5,000/- shall be deducted as processing charges from the refundable amount.
- c) All other cases of refund of fees will be decided on a case-to-case basis on its merit.
- d) The Seat Confirmation Fee is fully refundable in case of withdrawal of provisional admission within 30 days from the last date of admission.
- e) Fees shall be fully refundable in case a candidate fails to qualify the UG Examination.

#### Anti-ragging Guidelines

In order to curb the bad practices such as ragging on the University campus and in its affiliated colleges, the University authorities are committed to strictly take serious actions the matter as supported by the law and follow UGC Regulation on Curbing the Menaceof Ragging in Higher Educational Institutions, 2009

(https://www.ugc.gov.in/Bureaus/bureaus/details?EwV4Rtmy2xJ7nuhP3MYqbpwm5MTBRSa5u2ipRd ItuUxMTUu1gSiipessUFP0rnrG) as well as Goa Prohibition of Ragging Act, 2008 and the amendments carried out thereafter.

# All concerned must know what constitutes 'ragging'. Any or in multiples of the followingacts constitutes ragging:

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher.

Following functionaries are in place with defined responsibilities:

#### ANTI-RAGGING COMMITTEE

- Ensure the compliance of provisions pertaining to UGC Regulations on curbing the menace of Ragging as well as the provision of the Goa Prohibition of Ragging Act 2008 (and amendments)
- Monitor, oversee and guide the anti-ragging squad

# ANTI RAGGING SQUAD

- Make surprise raids on hostels, other hot-spots to inspect places of potential ragging on the campus
- Conduct an on-the-spot enquiry into any incident of ragging referred by any person and submit an enquiry report along with recommendations to the Anti-Ragging Committee for action under clause (a) 9.1 of UGC Regulations on curbing the Menace of Ragging in Higher Educational Institutions, 2009 and other relevant Rules/State Acts in force.

### MONITORING CELL

Co-ordinate with the affiliated Colleges and institutions to curb the menace of ragging

- Invite reports from the heads of the educational institutions in regard to the activities of the functionaries at their end,
- Conduct orientation programmes, counselling sessions, the incidents of ragging, the problems faced by the wardens or other officials.
- Keep abreast of the decisions of the District level Anti Ragging Committee.
- Review the efforts made by the institutions to publicize anti-ragging measures, soliciting undertakings from parents and students for each academic year to abstain from ragging activities or willingness to be penalized for violations
- Function as the prime mover for initiating action on the part of the appropriate authorities of the Goa University for amending its Statutes or Ordinances or Bye-laws as the case may be and to facilitate the implementation of Anti-Ragging measures at the level of the institutions
- Send the status reports periodically to the state level monitoring cell at the frequencies laid down with the support on logistics and smooth functioning from the <u>Directorate of</u> <u>Students Welfare</u>.

As a part of UGC's initiative towards reduction compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit. The revised procedure is as follows:

**Step 1:** A student will submit his/her details on the same website (<u>www.antiragging.in</u> and <u>www.amanmovement.org</u>) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the AICTE regulations on curding the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step is the same like before)

**Step 2:** The students will receive an e-mail with his/her registration number and a web link. The student will forward the link to the e-mail of the Nodal in his/her University/College. (Please note the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be case earlier)

**Step 3:** The Nodal Officer in the University/College can click on the link of any forwarded e- mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertaking in his/her college. The list will be updated every 24 hours.

It may be noted that it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year of the two designated websites, namely, <u>www.antiragging.in</u> and <u>www.amanmovement.org</u>.
